About us

UNISON CASH is a decentralized platform for new digital currency, which is backed by real assets.

Acceptance of Policy

Registration and using service is automatically a confirmation of acceptance and agreement with this privacy policy and other documentation. If you do not agree with the privacy policy, please do not use our services.

The site and services of UNISON CASH can be used by individuals and legal entities through their representatives.

Changes to our privacy policy

We may update this privacy policy to reflect changes to our information collection, usage and storage practices. If we make any changes that we deem as “material” (in our sole good faith discretion), we will notify you (using the notification methods set forth in the “notices” section prior to the change becoming effective. We encourage you to periodically review this document for the latest information on our privacy practices.

Information we collect and for which purposes

We collect information that is necessary for the functioning of UNISON CASH and the provision of services through it. We receive the information, such as username directly from you when you register at UNISON CASH. You may voluntarily provide us your contact information and related data, including personal information. We use the information in order to administer UNISON CASH and for internal operations, including troubleshooting, data analysis, testing, research, statistical and survey purposes. We may also store information that your computer or mobile device provides us in connection with your use of the service, such as your browser type, type of computer or mobile device, browser language, IP address and others. If you register at UNISON CASH using a third party service, we may receive information about you from such third party service.



Disclosure of your information

We do not rent or sell any information about you to others, or trade any such information, without agreement with you. We may employ third party companies and individuals to facilitate the operation of the UNISON CASH, and to perform services related to administration of the service (including, but not limited to, bill and credit card payment processing, maintenance, hosting and database management services, web analytics and administration). You understand and agree, that we may be required to disclose personal information. If required to do so by law or in the belief that such disclosure is reasonably necessary to avoid liability, to comply with legal process, including, but not limited to a subpoena, statute, search warrant, or court order, or to protect our, or a third party, property and rights, to protect the safety of the public or any person, or to prevent or stop activity we may consider to be, or to pose a risk of being, illegal, unethical or legally actionable. In the event we will be acquired by or merged with a third party entity, or in the event of bankruptcy or a comparable event. We reserve the right to transfer or assign personal information in connection with the foregoing events.

Cookies statement

We uses cookies. Cookies are small text files that are placed on your computer by websites that you visit. They are widely used in order to make websites work, or work more efficiently, as well as to provide information to the owners of the site. Cookies are typically stored on your computer's hard drive. Information collected from cookies is used by us to evaluate the effectiveness of our website and API, and any linked or directed (the "site"), analyse trends, and manage the platform. The information collected from cookies allows us to determine such things as which parts of our site are most visited and difficulties our visitors may experience in accessing our site. With this knowledge, we can improve the quality of your experience on the platform by recognizing and delivering more of the most desired features and information, as well as by resolving access difficulties. We also use cookies and/or a technology known as web bugs or clear gifs, which are typically stored in emails to help us confirm your receipt of, and response to our emails and to provide you with a more personalized experience when using our site. We also use third party service provider(s), to assist us in better understanding the use of our service and site.



Our service provider(s) will place cookies on the hard drive of your computer and will receive information that we select that will educate us on such things as how visitors navigate around our site, what pages are browsed and general transaction information. Our service provider(s) analyses this information and provides us with aggregate reports. The information and analysis provided by our service provider(s) will be used to assist us in better understanding our visitors' interests in our site and how to better serve those interests. The information collected by our service provider(s) may be linked to and combined with information that we collect about you while you are using the platform. Our service provider(s) is/are contractually restricted from using information they receive from our site other than to assist us. Your continued use of our site, as well as any subsequent usage, will be interpreted as your consent to cookies being stored on your device.

Security

Everything we save is encrypted and we have implemented the technical and organizational measures designed to secure your information from accidental loss and from unauthorized access, use, alteration or disclosure.

However, we cannot guarantee that unauthorized third parties will never be able to overcome those measures or use your information for improper purposes. UNISON CASH is not responsible for the relevant situations, unless there is direct evidence of the direct fault of UNISON CASH.

Processing of personal data while visiting our webpage

(1) If you use this website for information purposes only, i.e. if you do not otherwise provide us with information or do not register an account, we only collect the personal data that your browser transmits to our server.

(2) If you want to view our website, we collect the following data, which are technical necessary in order to show you our website and to ensure stability and security (legal basis is Art. 6 para 1 sentence 1 f) GDPR):

- IP-Address
- Date and time of your request
- Time zone difference to Greenwich Mean Time (GMT)



- Content of the request (specific page)
- Access status/HTTP status code
- Amount of data transferred in each case
- Website from which the request comes
- Browser
- Operating system and its interface
- Language and version of the browser software.

The information provided can be saved and stored with the hosting and information backup providers (such as Google cloud), held and operated by third parties other than UNISON CASH and/or which are not controlled by UNISON CASH.

Upon providing the information, the site visitor agrees and confirms that UNISON CASH may transfer to and/or save the information provided thereto on servers located in the any suitable jurisdiction.

Your rights

You may review, update, or delete the information collected by or through our service by logging into your account and reviewing your account settings and profile.

You have a right to access to your personal information held by us by requesting a copy in writing. We will provide you with such copy as soon as practicable after receiving a valid request.

We may charge you a fee, which shall not exceed the cost for copies. We may request proof of identification to verify your access request and reject any unfair request. To exercise this right, please refer to the “contact us” section below.



Notices

Notices to you may be made via our website. UNISON CASH may also provide notices of changes to this privacy policy or other matters by displaying notices or links to notices to you generally on our website.

You agree that all agreements, notices, disclosures and any other communications that UNISON CASH provide as aforementioned satisfy any legal requirement that such communications be in writing.

Objection or revocation to the processing of your data

(1) If you have given your consent to the processing of your data, you may revoke this consent at any time. Such a revocation influences the legitimacy of the processing of your personal data after you have submitted it to us.

(2) Insofar as we process your personal data on the basis of overweighting interests, you can submit an objection against the processing. This is the case, in particular, if the processing is not necessary for the performance of a contract that we concluded with you, which is described by us within the description of each functions. If such an objection is exercised, we ask you to please explain the reasons for which we should not collect your personal data as carried out. In the event of your justified objection, we will examine the situation and will either stop or adapt the processing of your data or inform you about our compelling reasons worthy of protection, on the basis of which we can continue the processing.
