TERMS & CONDITIONS

By accessing or using the UNISON CASH website and API, and any linked or directed (the “site”) and any services made available through the site, you (the “user” and collectively with others using the site - “users”) agree to be bound by these terms of use (“terms”).

By using the services or visiting the site, you signify your consent to all UNISON CASH documents, which may be modified from time to time at our sole discretion and without prior notice. Changes may be made to these terms from time to time. These changes will apply at that instant to all then current and subsequent uses of the site. You waive any right you may have to receive specific notice of such changes or modifications. Your continued use of this site acts as acceptance of such changes or modifications.

If you do not agree to the terms, you must stop using the site.

Use of the UNISON CASH website:

The purpose of our website is to provide you general information about the UNISON CASH’s product being developed and the services provided by UNISON CASH.

1. Eligibility

By accessing or using the site, you represent and warrant that you will not use the site if the laws applicable to you of due to your country of residency and/or citizenship prohibit you from doing so in accordance with these terms.

2. Services

UNISON CASH is a liquidity provider for the cryptocurrency trading

UNISON CASH provides deep liquidity of the highest quality for the operations with crypto currencies at the best market prices available at the moment.

3. Rules of use

The site and services of UNISON CASH can be used by individuals and legal entities through their representatives.

You represent and warrant that you have full right and authority to use the services and to be bound by these terms. You agree that you will comply fully with these terms and all applicable domestic and international laws, regulations, statutes, ordinances that govern your use of the services. Without limiting the foregoing and in recognition of the global nature of the internet, you agree to comply with all local and international rules regarding online conduct. You also agree to comply with all applicable laws affecting the transmission of content or the privacy of persons.



When using the site or services, you may not, nor may you assist other parties to pursuit or engage in unlawful or abusive uses, or any types of activities which contradict the purpose of the site or services, hinder the site's operation or services to other users, or which may be deemed to do so ("restricted uses"). For clarity and reference, restricted uses include, but are not limited to, these types of activities as detailed herein, as we may amend from time to time in our sole discretion (thus, not to be regarded as an exhaustive list):

a) Unlawful activities, such as activities which:

- (i) violate any applicable law, rule or regulation; or

b) Undermining or abusive activities, such as activities which:

- (i) take any action that imposes an unreasonable or disproportionately large load on our infrastructure, or detrimentally interfere with, intercept, or expropriate any system, data, or information;
- (ii) institute, assist or become involved in any type of attack (deliberate or other), including distribution of a virus, attacks upon the services, that prevent access to or use of any of the above, other attempts to disrupt any of the above, gain unauthorized access to any of the above, or disrupt any other person's use or enjoyment of any of the above;
- (iii) enter or make an attempt to enter the site and services (including by accessing linked platforms, networks or systems) unauthorized, including by password mining and/or by using other users information; use this website or links on this website in any manner that could interfere with, disrupt, negatively affect or inhibit other users from using this website or links on this website or that could damage, disable, overburden or impair the functioning of this website or our servers or any networks connected to any of our servers in any manner;
- (iv) design or assist in designing cheats, exploits, automation software, bots, hacks, modes or any other unauthorized third-party software to modify or interfere with the site or services;
- (v) attempt to disable or circumvent any security or access control mechanism of the site or services;

- (vii) bypass any robot exclusion headers or other measures UNISON CASH uses to restrict access to the services or use any software, technology, or device to send content or messages, scrape, spider, or crawl the service, or harvest or manipulate data;
- (viii) solicit another person's password or other personal information under false pretenses;
- (ix) copy, modify, or create derivative works of the services or the site;

c) Activities abusive to other users or their rights, such as activities which:

- (i) Interfere with other Users ability to exploit or access the site or any of the services;
- (ii) attempt to, or harass, abuse, or harm of another person or entity, including UNISON CASH employees and service providers;
- (iii) collect, harvest or post anyone's private information, in any media format;
- (iv) impersonate another user or otherwise misrepresent yourself;
- (v) violate the legal rights of others, including defaming, abuse, stalking or threatening users;

d) Activities infringing intellectual property, such as activities which:

e) Unfair or abusive transacting, such as activities which:

- (i) create or enter a fictitious transaction or a transaction with fictitious elements of any kind;
- (ii) exploit, disrupt or manipulate, or attempt to exploit, disrupt or manipulate the site or the use of the services, in a manner designed to create transaction conditions which are not available to other users;
- (iii) utilizes or applies technological abilities or foreknowledge not exploited or available to other users, to perform (including off site) transactions parallel to those performed by users on the site, and/or create unequal terms among users regarding the use of services on the site, or influence the terms of transactions on the blockchain (including activities commonly referred to as front-running) and/or create an unfair or abusive advantage over other users; violation of any of these restricted uses may be cause for the taking of legal actions on the part of UNISON CASH according to the law, in addition to any right and remedies set forth hereunder or under any applicable law. Without derogating from the above, by accepting these terms, you acknowledge that UNISON CASH makes no representation or warranty regarding its ability, nor assumes any liability, to detect, limit or prevent any restricted use.
- (iv) obtain or attempt to obtain any materials or information through any means not intentionally made available through this website or its services;
- (v) harvest or otherwise collect, whether aggregated or otherwise, data about others including email addresses and/or distribute or sell such data in any manner;
- (vi) use any part of this website other than for its intended purpose; or
- (vii) use this website to engage in or promote any activity that violates these terms.

4. Limitation or termination of access and services

We may, in our sole discretion, refuse to offer the services to any person or entity. We may, without notice and in our sole discretion, terminate your right to use the services or any portion thereof, and block or prevent your future access to and use of the services or any portion thereof. We may, at any time and for any reason, discontinue the services in its entirety, or any part hereof, without prior notice and/or liability of any kind. Subject to your agreement and compliance with these Terms, you are hereby granted with a personal, revocable, non-transferable and non-exclusive right to use the services. You hereby acknowledge that your right to use the services is limited by these terms, and, if you violate or if, at any point, you do not agree to any of these terms, your right to use the services shall immediately terminate, and you shall immediately refrain from using the services.



Without derogating from the generality of the foregoing, any use of the services that violates these terms is strictly prohibited and can, at UNISON CASH sole discretion, result in the immediate revocation of your limited rights granted by these terms. Without limiting any other remedy, UNISON CASH may limit, suspend, revoke, terminate, modify, or delete your Account or access to the services at its sole discretion without prior notice or liability, if you are, or if UNISON CASH suspects (in its sole discretion) that you are failing to comply with these terms or for any actual or suspected restricted use of the site and services. Any of such actions, including the termination of your rights to use the site and services, may be applied by UNISON CASH permanently or temporarily.

In such an event, UNISON CASH may terminate your account and access to the site and services (however without affecting your wallet, which remains exclusively yours, subject to any applicable terms of use or law). Upon termination of your account, your account log in credentials may not be reserved and it may not be possible to re-instate them. 12. Dispute resolution and governing law

These terms are governed by and construed in accordance with the laws of the Swiss Confederation. You hereby consent that any claim, cause of action or dispute arising out of or relating to these terms, the services or the site shall be submitted to the exclusive jurisdiction of court of England and you agree to submit to the personal jurisdiction of such courts for the purpose of litigating all such claims.

13. Miscellaneous

- a) The controlling language for these terms of use is English; the meaning of terms, conditions and representations herein are subject to definitions and interpretations in the English language. Any translation is provided for your convenience and may not be deemed to represent accurately the information in the original English.
- b) If any provision of these terms is determined to be invalid or unenforceable, the provision shall be deemed to be severable from the remainder of these terms and will not cause their invalidity or unenforceability.
- c) These terms of use may be amended from time to time. It is your responsibility to check these terms of use periodically for changes. Your continued use of the services following the posting of changes will mean that you accept and agree to the changes. If you do not agree with any such modification, you should not use the service.
- d) You agree that any cause of action arising out of or related to the services must commence within one (1) year after the cause of action accrues. otherwise, such cause of action is permanently barred.
- e) These terms are governed by the laws of Estonia. All claims arising out of or relating to these terms will be litigated exclusively in the courts of Estonia and we and you consent to personal jurisdiction in those courts.



- f) These terms control the relationship between us and you. They do not create any third-party beneficiary rights.
- g) If you do not comply with these terms, and we don't take action right away, this doesn't mean that we are giving up any rights that we may have (such as taking action in the future).
- h) If it turns out that a particular term is not enforceable, the term will be modified such that it is enforceable and this will not affect any other terms contained herein.
